The Natural right of citizens to bear arms is affirmed by both the United States Constitution and the Louisiana State Constitution

The United States Constitution Amendment II

A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

The LA State Constitution Article 1, Section 11:

"The right of each citizen to keep and bear arms is fundamental and shall not be infringed. Any restriction on this right shall be subject to strict scrutiny."

The right to carry a concealed weapon is affirmed and regulated by LRS 40:1379.3

Statewide permits for concealed handguns; application procedures; definitions A.(1) Notwithstanding any other provision of law to the contrary, the deputy secretary of public safety services of the Department of Public Safety and Corrections shall issue a concealed handgun permit to any Louisiana resident who qualifies for a permit under the provisions of this Section and may promulgate rules and adopt regulations regarding concealed handgun permits in accordance with the Administrative Procedure Act. The permit shall contain a permit number, expiration date, photograph, and the name, address, and date of birth of the permittee.

The right to open carry without a permit was affirmed in the Attorney General's statement:

Office of the Attorney General State of Louisiana Opinion No. 79-1212

"It is the conclusion of this office that it is legal to carry a gun when it is exposed on one's person. The Louisiana Supreme Court has affirmed this conclusion. State v. Fluker, 311 So.2d 863 (1975). However, the legality of carrying even an exposed gun is subject to certain limitations.



State v. Chandler, 5 La. Ann. 489, 52 Am. Dec. 599 (1850)

"In State v. Chandler, 5 La. Ann. 489, 490 (1850), the Louisiana Supreme Court held that citizens had a right to carry arms openly:

'This is the right guaranteed by the Constitution of the United States, and which is calculated to incite men to a manly and noble defense of themselves, if necessary, and of their country, without any tendency to secret advantages and unmanly assassinations."

Louisiana is a traditional open carry state. We have complete state preemption of firearms laws with the exception that laws in place prior to the passage of preemption are allowed to remain in place. In the United States, open carry is shorthand terminology for "openly carrying a firearm in public", as distinguished from concealed carry, where firearms cannot be seen by the casual observer.
